The elaborate and highly secretive preparations which went into the Zionist plan of forming and creating a State of Israel, located in what was then Palestine, became a reality on November 2, 1917, when Lord James Arthur Balfour stood before the British Parliament and announced that he had sent a letter to Lord Lionel Walter Rothschild, Chairman of The Zionist Federation, informing Lord Rothschild that his cabinet and His Majesty's Government "view with favor the establishment in Palestine of a national home for the Jewish people, and will use their best endeavors to facilitate the achievement of this object, it clearly being understood that nothing shall be done which may prejudice the civil and religious rights of existing non-Jewish communities in Palestine."

Lord Balfour's, now famous letter, became the first significant statement of political approval and recognition of Zionist ambitions by a major International Nation. It predated the Treaty of Versailles and the formation of the League of Nations by two years, the Second World War and its ensuing Holocaust by 22 years. The idea of an Israel was bigger, in many respects, than any other international event since the lunacy of the 1914-1918 Great War. Sir Winston Churchill then a member of that 1917 Parliament played his now familiar factotum role. He was later quoted as saying " I am a Zionist, let me make that clear. I was one of the original ones after the Balfour Declaration and I have worked faithfully for it." In April of 1920 at San Remo, Italy, Britain was conveniently and expediently given, by The League of Nations, a political and administrative Mandate to govern Palestine, the Transjordan, and Iraq regions of the Middle East. The League's authorization document read: " His Britannic Majesty as the Administrator for Palestine, ... ." Very cavalier language."

*Dear Lord Rothschild,*

*I have much pleasure in conveying to you, on behalf of His Majesty Government, the following declaration of sympathy with Jewish Zionist aspirations which has been submitted to, and approved by, the Cabinet.*

*"His Majesty's Government view with favour the establishment in Palestine of a national home for the Jewish people, and will use their best endeavors to facilitate the achievement of this object, it being clearly understood that nothing shall be done which existing non-Jewish communities in Palestine, or the rights and political status enjoyed by Jews in any other country".*

*I should be grateful if you would bring this declaration to the knowledge of the Zionist Federation.*

The various governments of Great Britain by self assumed Imperial powers have given the world a four hundred year history of conquering, colonizing, creating, dissolving and altering countries in Asia, Europe, Australia, North America, the Middle East, Africa, the Caribbean, and as far east as The International Date line. They have been a busy lot — intrusive, but very busy! This nation remodeling responsibility was passed on to their American cousins in 1945. The British are now resting and reaping their financial and hegemonic rewards. The harvest is substantial, indeed!

In 1749 the British established the Canadian city of Halifax in Mi'kmaq territory without consulting with the aboriginal tribal leaders. The native people of the Segepenegatig district seeing this foreign incursion into their ancestral domain asked themselves "where can we go if we are deprived of our lands?" In order to save their sacred land they copied a European custom by declaring war on the British colonists. The British were quick to label the native people as rebels. Governor Edward Cornwallis ordered his army to "take and destroy the Savages commonly called Mic-macks, wherever they are found." He ordered a bounty payment for native scalps at ever escalating rates, with no questions asked."

Three hundred years later we find a similar method of land takeover in the Middle East. Instead of human scalps, flag draped coffins are now the price to be paid for illegal land confiscation. The technology for killing innocents has improved greatly!

It is impossible to discover from the records of history the number of human lives that were lost in the four hundred year reign of domination that England and the British Empire had in Asia, Europe, Africa, North America, South America, the Caribbean, the Middle East, South East Asia, and in the Pacific. Entire nations and their peoples were enslaved and colonized — in every case against their will. Millions of Africans were captured, chained and shipped to far off foreign lands and cultures. How many died on the way will never be known. Those that survived were and remain strangers in a foreign land.

## BRITISH AFRICA

Africa was a vast repository of potential fabulous fortunes that could be quickly and easily made in the gold, diamonds, ivory and slave trades. It is easy to see why Victorian England was so ready to expand its empire into this mysterious and resource rich continent. England's African presence was significantly increased at the end of the First World War with its confiscation of defeated Germany's African colonies.

It is impossible to enumerate the number of global and local wars that Britain has involved itself in the past two hundred years. No other nation on earth has a like number. They were there only because of their history of provoking and initiating these wars. English greed and their wish to capture and control the riches of the earth irregardless of the number of British and other national military and civilian lives lost in each military and colonizing invasion and attack.

The Palestinian Mandate was a Leagues of Nations Mandate created in 1922 which gave Britain the Mandate Powers to govern Palestine between 1922 and 1948, a period known as "The British Mandate."

In 1922 it was Prime Minister H.H. Asquith, Sir Winston Churchill, Sir.Herbert Louis Samuelson, Sir.Alan G.Cunningham, and Earl Lloyd George. With the appointment of Sir.Herbert Samuelson as

High Commissioner to the Palestinian territory the British Parliament effectively became the legal government of the Palestinian Territory in what is generally known as The Middle-East. Most of the British Governments in this period were committed to a supportive agenda of the establishment of a Zionist State in their judgments and deliberations.

In 1939 it was Sir Winston Churchill, Lord Louis Mountbatten, Sir Anthony Eden, Lord Robert Cecil, and others that made up the War Political and Propaganda Machinery of England.

In 1956 Prime Minister Sir Anthony Eden, in conjunction with France and Israel tried to prevent Gamal Abdel Nasser, President of Egypt, from nationalizing the Suez Canal built in the 19th century by the Suez Canal Company through a concession from the viceroy of Egypt, but later owned by its British and French shareholders. Eden even responded by plotting to assassinate Nasser by enlisting Miles Copeland's assistance, since he was apparently a close friend of Nasser's. Others believed that Nasser was acting from legitimate patriotic concerns.

On 29th October 1956, the Israeli Army invaded Egypt. Two days later British and French bombed Egyptian airfields. British and French troops landed at Port Said at the northern end of the Suez Canal on 5th November. By this time the Israelis had captured the Sinai peninsula.

In 1991 The Persian Gulf War it was Prime Minister John Major and his cabinet

In 2003 it was Prime Minister Tony Blair, Gordon Brown, and Jack Straw who advocated and supported the United States invasion of Iraq, a Middle East nation once Britain Governed by the terms of the "Palestinian Mandate. At that period Iraq was the mortal enemy of the State of Israel after undergoing a treacherous surreptitious bombing attack by the Israeli Military Air force several years before the Bombing and Invasion and occupation of the city of Baghdad by USA Military forces.

All of these British Political and Military men were born as members of the British aristocracy, to a life of privilege and political and military power. Victorian England recognized, as gentlemen, those men and their sons that worked in the service of the country as clergymen belonging to the Church of England, army officers, and members of Parliament. They were aristocratic gentlemen by virtue of their birth and their occupation. They conceived, legislated, administered and directed England's many war efforts. They were never to be found in the trenches of war.
